Application processes will be done online through the application system (<http://yos.bilecik.edu.tr/>), and the originals of the registration documents must be delivered to the Institute by personally or notary power of attorney between **27 August – 3 September 2025** Otherwise, the student loses his right to final registration.

CONDITIONS of FOREIGN-NATIONAL STUDENTS

Foreign Students are to be accepted to the relevant programs in line with the provisions of the [“Directive on Admission and Registration of Foreign-National Students”](#) into Graduate Programs of Bilecik Şeyh Edebali University.

APPLICATION REQUIREMENTS AND EVALUATION

Applications are going to be made on the internet address <http://yos.bilecik.edu.tr/> until 17.00 on 20 August 2025. Candidates are required to upload the documents to the system in a complete form under the title of “**The Documents that Candidates Need to Upload on the Application Screen for Pre-Registration**”, “**Ön Kayıt İçin Adayların Başvuru Ekranında Yüklemesi Gereken Belgeler**” in Turkish

- a) Candidates who will apply to M.Sc. programs must have a bachelor’s degree from a university recognized as equivalent by the Council of Higher Education, Yükseköğretim Kurulu (YÖK) in Turkish.



- b) Candidates who will apply to Ph.D. or Proficiency in Art programs must have a bachelor's degree or M.Sc. degree with Thesis from a university recognized as equivalent by YÖK. Candidates who will apply to the Doctorate/Art Proficiency program with an undergraduate diploma must have an undergraduate GPA of at least 3.00 out of 4.00.
- c) Evaluation of the applications for the announced quotas, execution of the placement procedures, and resolution of the objections are carried out by the "Foreign Student Admission Commission".
- d) Foreign-national candidates who will apply to graduate programs;
- Candidates continue their education at the postgraduate level provided that they are certified with a Turkish proficiency level of C1 and above.
 - Candidates who do not have a Turkish proficiency certificate must take the Turkish course from our University Turkish Teaching Application and Research Center (TÖMER) or from other units accepted by TÖMER.
 - Candidates coming within the scope of International Protocols, upon request ([click for request petition in Turkish Language](#)), can take Turkish preparatory education at another Turkish Teaching Centres of State or Foundation Universities. During TÖMER Education, students within the scope of International Protocols are need to take and pass "LEE5998 Academic Turkish" course.
- e) Students who have registered and successfully completed the STS (Level Determination Exam) conducted by TÖMER by October 17, 2025 can start postgraduate courses in the Fall Semester of the 2025-2026 Academic Year.
- f) Candidates who have graduated from secondary or higher education institutions in Türkiye that provide education in Turkish are not required to have a Turkish proficiency certificate and continue their education at the postgraduate level.
- g) Candidates may apply to more than one program, but they can only register in one program. Applications are only accepted made via the internet address (<http://yos.bilecik.edu.tr/>).
- h) In calculating the success score of the candidates, only the undergraduate graduation grade point is taken into consideration for M.Sc. applications. In applications to Ph.D. programs, only the graduate grade point is taken into consideration. The ranking of the success points of the candidates is evaluated only by using 100-point grading from the highest score to the lowest score, and their admission to studentship within the determined quota is finalized by the Decision of the "Graduate School Administrative Committee". If the candidate does not have a 100-point grading average, the 100-point grading equivalent of YÖK's grade conversion table is taken into account upon evaluating the ranking.
- i) Even if the candidates' transcripts or diplomas have points of the equivalent of the 4-point grading system of the 100-point grading system, the grade conversions are made according to the grade conversion table of YÖK.
- j) The application fee for graduate programs is **2500 TL**. (Except for applicants within the scope of International Protocols)

 - The deposited application fee, education coaching service fee, and tuition fee are not refunded to the student under any condition.



- l) Candidates applying through lateral transfer will be evaluated according to the “Regulations of Graduate Education and Examination” of our University. Candidates applying through lateral transfer must have a Turkish language proficiency level of C1, as accepted by TÖMER of Bilecik Şeyh Edebali University or must have graduated from secondary or higher education institutions in Turkey that provide Turkish education. Also, students applying for lateral transfer must send their current student status and current transcripts to lisanustu@bilecik.edu.tr by e-mail within the application dates after applying through the system.

The Documents that Candidates Need to Upload on the Application Screen for Pre-Registration

- a) The Diploma or the graduation certificate and the Turkish translation of the graduation certificate approved by the Turkish Embassy in their country, the Turkish Consulate, or a notary in Türkiye.
- b) For candidates who graduated from a university outside Türkiye, a document showing the equivalence of the graduation certificate by YÖK. The equivalence certificate is for health programs with clinical practice (If any).
- c) The Undergraduate/Master's approved transcript and the Turkish translation of this document certified by the Turkish Embassy in their country, the Turkish Consulate, or a notary public in Türkiye.
- d) The pages of the official ID or Passport showing the identity information and their Turkish translation approved by **the Turkish Embassy in their country, the Turkish Consulate, or a notary in Türkiye.**
- e) A certificate of recognition from the YÖK (If any).
- f) A receipt of application fee

Documents to be Requested from Foreign-national Students at Final Registration

1. A Printout of the application form.
2. The diploma or the graduation certificate and the translation of the graduation certificate certified by the Turkish Embassy in their country, the Turkish Consulate, or a notary in Türkiye.
3. For candidates who graduated from a university outside Türkiye, a document showing the equivalence of the graduation certificate by YÖK. The equivalence certificate is for health programs with clinical practice. (If it is not submitted to the Institute by **September 18, 2026**, the student's relationship with the Institute will be dismissed.)
4. The Undergraduate/Master's approved transcript and the Turkish translation of this document certified by the Turkish Embassy in their country, the Turkish Consulate, or a notary in Türkiye.
5. One 4.5x6.0 cm passport size photograph (photos must be taken in the last six months and must be in a way that can easily identify the candidate).
6. Official ID or passport pages showing the identity information and their Turkish translation certified by the Turkish Embassy in their country, the Turkish Consulate, or a notary in Türkiye.



7. A document showing exemption of Turkish language education (if any).
8. Recognition Certificate received from the YÖK Presidency (If it is not submitted to the Institute by **September 18, 2026**, the student's relationship with the Institute will be dismissed.)
9. The Student visa or valid residence permit obtained from the Embassies/Consulates of the Republic of Türkiye for citizens of countries that are not exempt from visas by agreements to which the Republic of Türkiye is a party or by the decision of the Council of Ministers. (If it is not submitted to the Institute by **September 18, 2026**, the student's relationship with the Institute will be dismissed.)
10. Bank receipts showing TÖMER and tuition fees have been paid.
11. A financial support letter showing that the Education Coaching Service Fee will be covered by their country for students who come with an international protocol.
